## REGISTRATION

To enroll in a summer school course, Regents Review or take a Regents examination:

1. Complete a Summer School Registration Form (available from high school guidance counselors after June 1) listing **each** course, Regents Review, or Regents exam you want to take.
  - Students who have an **IEP or special accommodations** must indicate so on the registration form and attach the appropriate documentation to the form.
  - Students **from non-participating districts** must attach proof of immunization.
2. **Make an appointment with your guidance counselor prior to registration because your completed application must be signed by the home school principal, guidance counselor or designee.**
3. **Submit the Summer School Registration Form in-person on Monday, July 6<sup>th</sup> (open registration for participating and non-participating districts) at the registration location listed on page 2.** The student will be placed in the appropriate class or examination list(s) at registration.
4. **Registration is not transferable to another campus unless required by Western Suffolk BOCES for enrollment purposes.**
5. All fees must be paid in full at registration.
6. **THE LAST DAY TO REGISTER FOR REGENTS REVIEW OR REGENTS EXAMS ONLY IS JULY 17<sup>th</sup>.**

## REFUNDS

No refunds will be made for any reason other than the cancellation of a class for insufficient enrollment.

## REGISTRATION PRIORITY

Priority is given to students residing in participating districts. Registration of all other students (from non-participating districts) is contingent on seat availability.

## **REGENTS REVIEW CLASSES**

To sign up for Regents Review classes, submit the Summer School Registration Form in-person at the time of Summer School registration on Monday, July 6<sup>th</sup> (open registration for participating and non-participating districts) at the registration location listed on page 2. Regents review classes are offered to students preparing to take a Regents Examination in August. These classes are scheduled for eight school days prior to the exams:

**Hours: 12:00 p.m. to 1:00 p.m.**

**Dates: August 3<sup>rd</sup>, 4<sup>th</sup>, 5<sup>th</sup>, 6<sup>th</sup>, 7<sup>th</sup>, 10<sup>th</sup>, 11<sup>th</sup> and 12<sup>th</sup>**

While the review classes are open to all students, they are designed for those students who did not enroll in summer school but who plan to take a Regents examination. Notice of insufficient enrollment, thus class cancellation, will be made by July 31<sup>st</sup>. **A student can enroll in only one Regents Review class.**

## **TRANSPORTATION**

Western Suffolk BOCES does not provide transportation to and from summer school. Please contact your home district for arrangements.

## **HEALTH and SAFETY IMMUNIZATION**

In accordance with New York State Education Law and New York Public Health Law, every student-attending summer school is required to furnish the school with proof of immunization against polio, mumps, measles, diphtheria, and rubella (German Measles).

## **SCHOOL NURSE**

A registered nurse will be on duty during school hours.

## **MINIMUM REGISTRATION REQUIREMENT**

Any course listed will be offered only if there is sufficient enrollment.

## **LIBRARY**

The Library will be open daily from 7:45 am to 11:34 am under the supervision of a librarian.

## **ATTENDANCE**

Summer school students are expected to attend all classes in order to experience maximum instructional benefit. Attendance is taken each class period and recorded based on host district guidelines for excused and unexcused absences. Legal reasons for absence, according to New York State Law, include the following: illness of a student or family member, death in the family and/or required court appearances. Students who have excused absences may be provided the opportunity to make-up missed work.

An excused absence note should be submitted the day the student returns to class. All tests and missed work during the absence must be made up and submitted to the teacher as soon as possible. Class participation is factored into a student's summer school grade. Poor attendance coupled with the lack of class participation or completion of assigned work may result in a student not earning a passing grade for the class. **More than three (3) unexcused absences will likely result in a student being unable to earn sufficient points to pass the class.**

## **GRADING POLICY AND REPORT CARDS**

The passing grade for examinations and courses is 65. Final examinations or Regents exams will be given in all subjects 6 - 12. Grades will be based upon an evaluation of the student's class work, special reports, class participation, homework and tests. The same standards of evaluation that normally apply during the regular school year are applied in summer school.

Students will receive a Mid-Summer Progress Report after three weeks and a Summer School Report Card at the conclusion of the program. These reports are sent to the student's home address and the home district. Reports include the final exam grade, Regents examination grade, final course grade,

days absent and days late. The Summer School Report Card is also used to report examination grades for students who register only for a Regents and examination.

**Important:**

- Neither the summer school office or the home school guidance department will give final grades or Regents grades out by phone.
- No grades will be released for any student who has not returned textbooks or has other outstanding obligations.

## **CREDIT**

**Home school districts** determine the final course grades and the awarding of course credit for courses completed in summer school.

## **SCHOOL REGULATIONS**

1. All Students will be subject to the host district's Code of Conduct.
2. Smoking/vaping will not be permitted in the building or on school grounds. Students may not smoke in cars, in parking lots, or on any streets or private property adjacent to school property. Violators will be subject to be released from Summer School.
3. Student parking is available on a limited basis. Driving/parking at summer school is a privilege. Students will be required to register their vehicle with the Summer School Principal. Violators of traffic or parking regulations will lose their privilege and be faced with suspension. The speed limit on school property is 15 M.P.H. Students are only permitted to park in the student parking area. There will be someone on duty during arrival and departure times to direct you.
4. All students are expected to respect the rights, property and safety of others. There is a "No Tolerance" policy in effect for violations of student and staff rights, property or safety. Any student who disregards these rights is subject to discipline and/or legal action, including the expulsion from summer school.
5. The Western Suffolk BOCES Regional Summer School attempts to reinforce the participating school district's tradition of good taste concerning attire. We encourage modesty in dress and discourage students from carrying fads and fashion to extremes. See-through clothing, short-shorts, soiled and torn clothing are not appropriate school attire. Clothing designed for beachwear, or clothing considered extreme, distracting or disruptive is not permitted. The wearing of clothing that is potentially dangerous to others, i.e. metal ornaments, spikes, spiked bracelets, etc., is not appropriate. Students who are not dressed appropriately will be asked to call their home and arrange for a change of acceptable clothing. Students may be suspended or dismissed for improper attire.
6. For reasons of safety and health, footwear is required while students are on school property. Bare feet are not permitted.

7. All students must enter and exit the building through the designated doors, except during fire/safety drills and emergencies.

## WESTERN SUFFOLK BOCES REGIONAL SUMMER SCHOOL 2026

### STUDENT RESPONSIBILITIES

**All students will be subject to the host district's Code of Conduct available in the Regional Summer School Principal's office.**

Each student is required to adhere to a code of conduct that will insure that all students have an equal opportunity to a quality education.

*Students in violation of the code of conduct will be asked to leave the summer program and not return.*

1. All students are expected to respect the rights, property and safety of others. There is a "No Tolerance" policy in effect for violations of student rights, property or safety. Fighting or any acts of violence, harassment or intimidation is strictly prohibited. Any student who engages in these behaviors will be asked to leave the summer school program and not return. Any student who disregards these rights is subject to discipline and/or legal action, including the expulsion from Summer School.
2. The Western Suffolk BOCES Regional Summer School reinforces the use of good taste concerning school attire. We encourage modesty in dress and one that encourages students from carrying fads and fashion to extreme. Therefore, see through clothing, short-shorts, soiled and torn clothing are not appropriate school attire. Clothing designed for beachwear, or clothing considered extreme, distracting or disruptive is not permitted. The wearing of clothing that is potentially dangerous to others is not appropriate. Students who are not dressed appropriately will be asked to call their home and arrange for a change of acceptable clothing. Students may be suspended or dismissed for improper attire.
3. For reasons of safety and health, footwear is requirement while students are on school property. Bare feet are not permitted.
4. Smoking/ Vaping is strictly prohibited in the building or on school grounds. Students may not smoke in cars, in parking lots, or on any streets or private property adjacent to school property. Violators will be subject to be released from Summer School.

  - a. Cell phones
  - b. Beepers
  - c. Radios, Walkman or other electronic devices.
7. The following items are not permitted in school:
  - a. Weapons of any kind (Even something like a Swiss Army Knife or anything that can be identified as a weapon)
  - b. Medication
  - c. Large sums of money
  - d. Expensive jewelry

## Western Suffolk BOCES Regional Summer School

### Grading

All students are encouraged to perform to the utmost of their capabilities. Grade reports are issued periodically to indicate to the student and parents how well he/she is performing. Grades will be based upon an evaluation of the student's class work, class participation, special reports, homework and tests. The same standards of evaluation that normally apply during the regular school year will also apply in the summer. Passing summer school work should not be based only on attendance.

Teachers will be responsible for keeping a well-organized grade book record. Grade books will be checked during the summer school for teacher's name, subject, year, daily register, test, and quiz records. Teachers should clearly label the nature of each grade as well as the date of the test or assignment. A key should be included so that the grade book can be interpreted when the teacher is gone. These records will be submitted at the end of the summer as the teacher's official record and retained for future reference.

Grading will consist of the following components

- 80% of the course grade will be based on **participation**, including attendance, completion of assignments, tests/quizzes, engagement in class activities and effort
- 20% of the course grade will be based on **tests**, specifically mid-term and final examinations

### Participation Points

The summer program consists of 24 instructional days. Each day, students will have the potential of 5 participation points, based on 1 – 3 points for effort and 1 -2 points for attendance.

### Final Grade

The final grade is composed as follows:

- 80% based on the grade equivalence of the **participation points**
- 20% based on the average of the **tests**, specifically mid-term and final examinations

**Credit Awarded** Final course credit will be determined by the home school district for the purpose of the student's permanent school record. Each school district gives the summer school final grade a percentage value to determine the student's final grade for the course. Each district may have a different policy. The passing grade for Western Suffolk BOCES Regional Summer School is 65.

## **USE OF INTERNET-ENABLED DEVICES DURING THE SCHOOL DAY**

Western Suffolk BOCES consulted with stakeholders to develop this policy to prohibit the use of Internet-enabled devices by students during the school day on school grounds. This policy aims to ensure that students remain focused on their academic responsibilities throughout the school day, which includes all instructional and non-instructional periods such as homeroom, lunch, recess, study halls, and passing time.

For purposes of this policy, the following definitions apply:

a) "Internet-enabled devices" means and includes any smartphone, tablet, smartwatch, or other device capable of connecting to the Internet and enabling the user to access content on the Internet, including social media applications; "Internet-enabled devices" does not include:

1. Non-Internet-enabled devices such as cellular phones or other communication devices not capable of connecting to the Internet or enabling the user to access content on the Internet; or

2. Internet-enabled devices supplied by the District, charter school, or Board of Cooperative Educational Services (BOCES) that are used for an educational purpose.

b) "School day" means the entirety of every instructional day as required by subdivision 7 of the Education Law Section 3604 during all instructional time and non-instructional time, including but not limited to homeroom periods, lunch, recess, study halls, and passing time.

c) "School grounds" means in or on or within any building, structure, athletic playing field, playground, or land contained within the real property boundary line of a BOCES facility.

Students are generally prohibited from using Internet-enabled devices during the school day anywhere on school grounds.

However, students may be authorized to use an Internet-enabled device during the school day on school grounds:

- a) If authorized by a teacher, principal, or agency for a specific educational purpose;
- b) Where necessary for the management of a student's health care;
- c) In the event of an emergency;
- d) For translation services;
- e) On a case-by-case basis, upon review and determination by a school psychologist, school social worker, or school counselor for a student caregiver who is routinely responsible for the care and well-being of a family member; or
- f) Where required by law.

Students must be permitted to use an Internet-enabled device where the use is included in the student's:

- a) Individualized Education Program (IEP); or
- b) Section 504 Plan.

**On-Site Storage of Internet-Enabled Devices Including Cell Phones:**

- Students are discouraged from bringing their personal devices to school. If students do bring devices to school, they must store their Internet-enabled devices in designated storage areas during the school day

**Methods for Parents to Contact Students During the School Day**

- To accommodate necessary communication, parents or persons in parental relation may call the school's main office, and the office staff can relay messages to the student or call the student to the office to speak with their parent or person in parental relation.

**Enforcement and Consequences:**

- Western Suffolk BOCES is prohibited from suspending a student solely for accessing internet-enabled devices in violation of this policy. However, some uses of personal electronic devices or refusal to adhere to this policy will constitute a violation of the Code of Conduct or other district policies, and in some instances, the law.
